Any other disturbance of the Property is allowed only if such disturbance of the final cover or other component of the containment system, including any removal of coal combustion residual, is demonstrated and such demonstration is certified by a qualified professional engineer to not increase the potential threat to human health or the environment and notification of such disturbance is made to the Director, Missouri Department of Natural Resources.

The obligation to maintain the restrictions set forth above shall run with the land and shall remain in effect in perpetuity.
