LIQUOR TASTING LICENSE
Revised October 1, 2004

Applications for a liquor tasting license must include a written proposal on how the applicant will ensure that the liquor tasting is a controlled event, how often they plan to hold liquor-tasting events and how they plan to notify customers of the liquor tasting event.

Applicants for this license must already have a current Retailer of Intoxicating Liquor in the Original Package License and a current City of Independence Business License before the Liquor Tasting License will be issued. The fee for this license is \$37.50. All required forms and fee must be brought or mailed to the City of Independence License Division at the City of Independence City Hall located at 111 E. Maple, P O Box 1019, Independence, MO 64051.

It is required that the Store Manager or Liquor Department Manager monitor the liquor tasting event and all employees serving samples must have a current City of Independence Employee Liquor Permit.

The following regulations must also apply:

- ✓ The licensee may not serve samples to minors.
- ✓ Each sample offered adults may not contain more than one-half (1/2) ounce of alcoholic beverage.
- ✓ The licensee may not serve more than one (1) sample of each brand of alcoholic beverage per customer per day.
- ✓ The licensee may not serve more than two (2) products of alcoholic beverages per day.
- ✓ Liquor tasting is only allowed in the liquor department of the licensed premises.
- ✓ Liquor tasting is allowed only between the hours of 12:00 p.m. and 6:00 p.m. on Sunday, 12:00 p.m. and 8:00 p.m. on Monday through Thursday and 12:00p.m. and 9:00 p.m. on Friday and Saturday.

After Approval - When your application is approved, this office will mail a City Approval Letter required for the application of the State of Missouri Liquor Tasting Permit. Once the license is printed and signed it will be mailed to the licensed business. For more information on obtaining a State permit, call (573) 751-2333 .
